

Cucurbits, granadillas	Pumpkin fly	17,5 ml + 800 g Sugar	<b>Bait treatment:</b> Apply 3 – 4 l/100m <sup>2</sup> as a coarse droplet spray onto underside of foliage. For small plots, repeat application twice per week. For large plots repeat application weekly and after rain.
Fruit	Fruit fly	17,5 ml + 800 g Sugar / 20 ml Protein or 60 g fish oil	
Public health	Carpet beetles, flies, ants, bedbugs, cockroaches, fishmoths	50 ml / 1 l	Coarse spray or brush onto surfaces.

### WAARSKUWINGS:

Moenie toedien binne die volgende dae voor oestyd nie:

- Piesangs, guavas, perskes, pruime, appelkose en vrugte binne 10 dae.
- Grinadella's, avokadopere, papaja, sitrus, boontjies, koolgewasse en uie binne 7 dae.
- Pampoengewasse, sampioene en tamaties binne 1 dag.

Hanteer versigtig. Giftig deur kontak, innname en inaseming. Hou buite bereik van oningelegte persone en diere. Stoor agter slot en rendel, weg van voedsel en voer. Giftig vir bye, vis en wildediere.
